1. Entry form should be send to the Lithuanian Kennel Club with a copy of pedigree, champion and/or FCI working certificate and payment (with clearly legible name of the payer!) enclosed. Only dogs with complete set of relevant documents enclosed will be accepted.
2. Entry fee must be transferred to the Lithuanian Kennel Club bank account in full amount (including bank charges). Cheques are not accepted!
3. Change of dogs or entry cancellation is not allowed.
4. Entry fee can be refunded only in case of death of dog or cancellation of the show.
5. The discount for the 2nd and next dogs can be applied only if the name of the owner and his/her address is completely identical with the 1st dog entry form.
6. Entries by e-mail and post are accepted. Entries by fax are unacceptable.

The entrant/exhibitor declares that any dog entered has been adequately vaccinated (standard vaccinations, the validation of the vaccination in accordance with the vaccine's producer advise) of which proof can be shown. Dogs coming from abroad are required to have been vaccinated against rabies and distemper which must be recorded in a European pet passport. If the dog is vaccinated for the first time or if the term of revaccination has passed, it must be more than 21 day period since the new vaccination that the dog could participate in the show. Only dogs which are more than 4 months of age can enter the showplace. All the dogs must be identified with microchip or clearly readable tattoo. Under the order No. B1-2 of 2 January, 2013, of the State Food and Veterinary Service, participation in dog shows is prohibited for cropped and/or docked dogs born in the Republic of Lithuania later than 1 January 2013. This prohibition does not apply to the dogs who come from the countries where cropping/docking is still permitted or it was so at the time when the dog was born, and the owner can prove the fact by relevant documents. In case of breach of the rule, the participant will be eliminated from the show and the entry fee will not be refunded.
